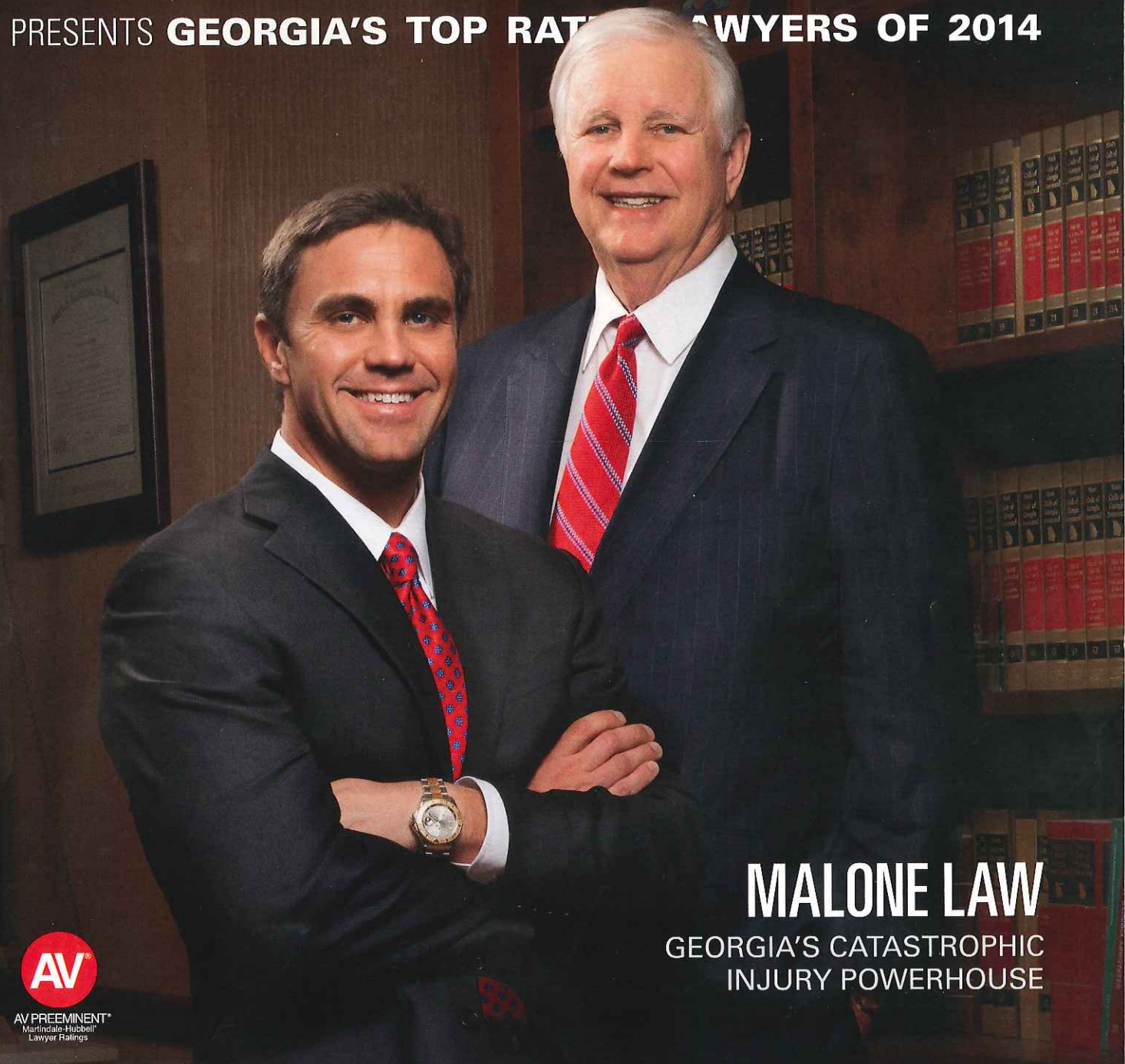

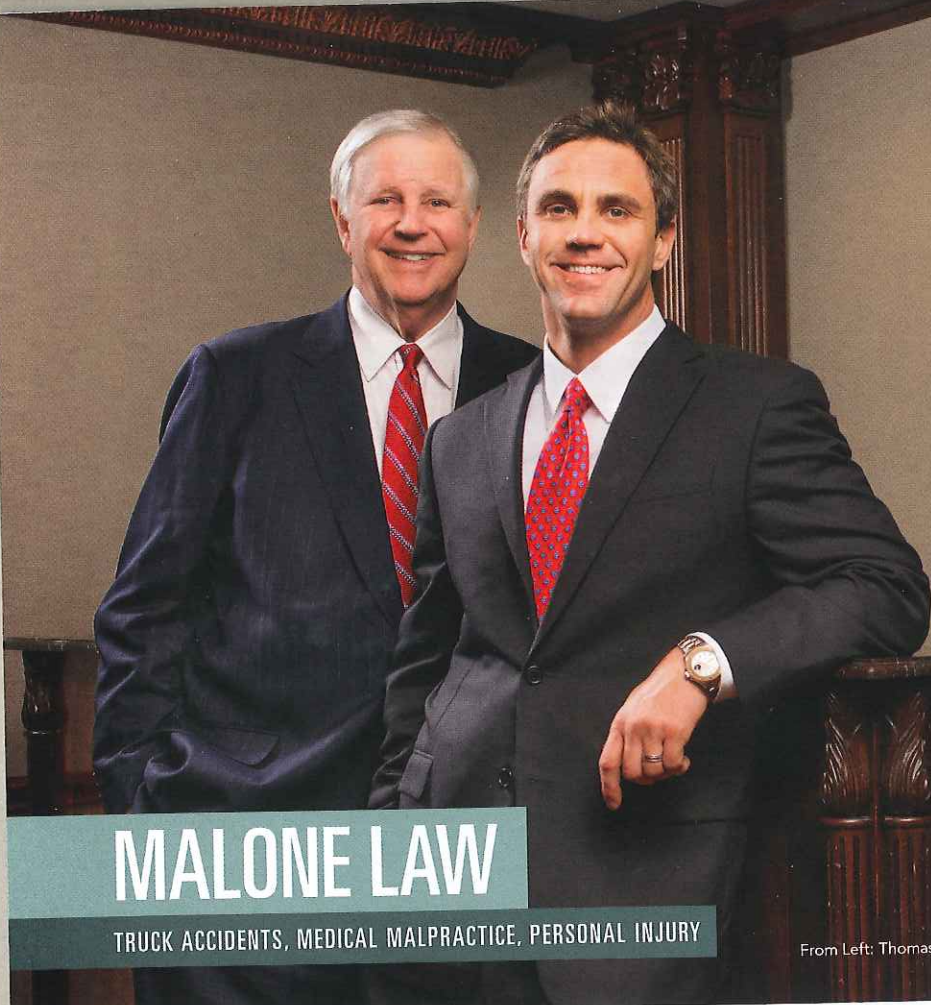

TOMMY MALONE AND HIS SON AND LAW PARTNER, ADAM MALONE, LIMIT THEIR PRACTICE TO CASES involving severe injury and wrongful death, whether those cases were caused by carelessness on the highway, in the hospital, or elsewhere. Veteran attorney Thomas W. "Tommy" Malone is inspired daily by the "belief that I can make a meaningful difference in the lives of others." In addition to his record-setting verdicts in medical negligence cases, Tommy is understandably proud of a \$49 million verdict he obtained for a young man in California who suffered a traumatic brain injury as the result of a commercial trucking collision.

TOMMY AND ADAM ARE NATIONALLY KNOWN TRIAL Lawyers. Both are AV Preeminent[®] rated by Martindale-Hubbell and are selected annually for inclusion in The Best Lawyers in America and Super Lawyers. Tommy was named to the 2013 class of the Carter Center Board of Councilors, an organization that works with former President Jimmy Carter to serve as a link between the community and the Carter Center.

TOMMY MALONE, A PIONEER IN HIS FIELD, HAS published two books on jury selection and closing arguments, and has contributed numerous book chapters and professional articles on trucking industry liability, medical negligence, and traumatic brain injury.

ADAM MALONE HAS ALSO OBTAINED MULTIMILLION-dollar recoveries for the victims of negligence in cases resulting in wrongful deaths and catastrophic injuries. Adam frequently speaks to organizations across the country, sharing his trial knowledge and experience. In 2012, he was inducted as a fellow into the International Society of Barristers and was honored by the American Association for Justice (AAJ) with the Wiedemann & Wysocki Award, which is bestowed upon members deemed to have exceeded their commitments to the principles of the civil justice system and the AAJ.

IN ADDITION TO MANY MULTIMILLION-DOLLAR recoveries for traumatic brain injury, paralysis, and death caused by negligent truck drivers and others, Adam's achievements include his role as lead counsel in a medical negligence case that resulted in a 2010 change in Georgia law where the Supreme Court held legislative caps on non-economic damages to be unconstitutional. This landmark decision returned power to the state's citizen jurors to hear the evidence in each case and determine the value of all losses suffered by those injured by negligence.

THROUGH THE SKILLFUL HANDLING OF COMPLEX cases, Tommy and Adam Malone have earned a reputation of excellence. This reputation has become their tradition as they continue to achieve just compensation for those they are privileged to represent.
